### 1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.

In 2020-21, the Council made payments totalling £34,731 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

## Auditor General's report

### Audit opinion - qualified

Except for the matters reported below, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis of qualification

In my opinion, the Annual Governance Statement is inconsistent with the Council's governance arrangements in place during the year.

- The Accounts and Audit (Wales) Regulations 2014 require the Council to ensure that there is a sound system of internal control in place. The Council states in its Annual Governance Statement that it has maintained an adequate system of internal control during the year. However, the Internal Audit report presented to the Council identifies significant deficiencies in controls related to payments.

### Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations that should be considered and addressed by the Council

- The internal audit report provides an important source of assurance for the Council's assessment of its internal control and governance arrangements. The Annual Governance Statement should take into account the findings set out in the internal audit report.
- We recommend that for 2021-22 onwards, the Council carefully considers the outcome of the Internal Audit when it determines the appropriate responses for the Annual Governance Statement
- We recommend that the Council reviews its arrangements for processing invoices to address the deficiencies identified by Internal Audit


